

TERMS AND CONDITIONS AWARDS IN-USE POOL FACILITIES PISCINA BARCELONA 2025

One. COMPANY ORGANISING THE PROMOTION AND PARTICIPANTS

1. FIRA INTERNACIONAL DE BARCELONA (Fira de Barcelona), with its registered address at Avda. Reina M^a Cristina, s/n 08004 (Barcelona) and identification no. Q0873006A, is organising the Innovative Product Award as part of Piscina Barcelona 2025 (hereinafter, the event).
2. The scope of this Competition is international, it will be conducted through the Internet and it is exclusively for persons of legal age.

Two. START DATE AND END DATE PROMOTION

- 2.1. The Promotion will start on 30 April 2025 and end on 20 September 2025.

Three. CATEGORIES AWARD IN-USE POOL FACILITIES

The **2025 Piscina Barcelona Awards** are open to newly-built and renovated residential and public pools, provided that they were completed between **1 September 2023 and 31 August 2025**.

This competition, organised by **Fira de Barcelona**, will acknowledge projects in the following categories:

- **Best Residential Pool**
- **Best Public Pool (sports facilities, water parks, hotel, campsite and community pools)**

Four.

The following individuals are eligible to take part in this call:

1. **Project owners:** Natural persons who are the project owners, as well as the legal representatives of the entities responsible for projects related to residential and public pool facilities.
2. **Agents involved in the execution of the project:** Proposals may also be submitted by agents who have been involved in the execution of the project, including developers, designers, construction or execution managers and builders, provided they receive the project owner's authorisation.

Responsibility for the proposal

- The person who submits the proposal will be responsible for the accuracy of the information provided to the Organisation.

Number of proposals

- As many proposals as are deemed appropriate may be submitted; however, each proposal must have been registered separately.

Participation conditions

- Participation in the Awards will only be valid if the documentation indicated in section 5 of these Terms and Conditions is submitted.

Five. **FORMALISATION OF PARTICIPATION IN THE COMPETITION**

5.1. In order to participate, interested parties must fill in the form available, providing the following information:

- Information on the participant
- Description of the project
- Additional documentation required for evaluation

Registration form

- The registration must be completed exclusively online, using the form available on the website (add link) before **11:59 pm (GMT+2) on 20 September 2025**.

- After the registration has been completed, the project data sheet included on the form must be filled in with the required information.
- The project data sheet must be submitted in A4 and .pdf format and must not exceed two pages in length.
- Plans required to understand the project in **.pdf format**.

5.2. Project data sheet

The project data sheet will consist of two pages with the following information:

- **Page 1:**
 - Type of construction, location and date of completion.
 - Details of the owner of the project or the agent who submits the proposal (with the authorisation of the project owner).
 - Details of any other agents who have been involved in the project (designer, construction or execution manager, builder, pool installer).
 - Description of the project.
 - Innovative and sustainable elements incorporated into the project.
- **Page 2:**
 - Exclusively graphic content: photographs and plans.
 - Images may be included in **JPEG (300 dpi)** or **TIFF (300 dpi, actual size) format**.

Project data sheets exceeding two pages will not be accepted.

5.3. Additional information

In addition to the project data sheet, the following must be included:

- Medium-high quality image of the company logo **(85x815 pixels)**

Even though the images and plans have been incorporated into the project data sheet, they must be sent separately in the required formats. To facilitate file uploads, a dedicated section will be enabled on the platform.

5.4. End-of-Project Document or Certificate

- **Mandatory documentation**

- A certificate issued by the corresponding official certifying the completion date of the project must be attached in .jpg or .pdf format.
- All the required documents (project data sheet, additional information and completion certificate) must be uploaded onto the platform in the spaces designated for each section.

- **Submission language**

- The information must be submitted in Spanish and English. Proposals in other languages will not be accepted.

- **Participation conditions**

- Participation in the awards is free of charge.
- The registration will only be valid if all the documentation is submitted by the established deadlines.

5.5. Details of the process:

- Once registered, participants will receive a confirmation email at the address indicated on the form.
- All the information must be fully submitted in **Spanish and English**. Proposals in other languages will not be accepted.

The deadline for registration and receiving the supporting technical and graphic information is **11:59 pm (CET) on 20 September 2025**.

5.2. The Technical Committee will select **three finalists** in each category:

- **Best Residential Pool**
- **Best Public Pool (sports facilities, water parks, hotel, campsite and community pools)**

The projects in the final will be exhibited in the **Innovation Zone** in the following participation format:

1. POSTER (Free)

- Selection as a finalist automatically entails a poster-format presentation of the product in the Innovative Product exhibition area of the Innovation Zone.
- The poster will include:
 - Name of the company and product.
 - Description of the product.
 - Photo of the product.

Six. SELECTION CRITERIA

The Committee for the In-Use Pool Facilities Awards will acknowledge projects and facilities that deliver significant value to the businesses and initiatives into which they are integrated.

The assessment of these projects will be based on the following criteria:

- **Qualitative impact and differentiation**
The discursive power of the project and its ability to improve market positioning and differentiation will be considered.
- **Operational improvements**
The operational improvements generated will be evaluated by means of performance metrics.
- **Sustainability**
Special recognition will be given to projects that promote sustainability by means of the efficient use of resources such as water, energy and raw materials and display respect for the environment.
- **Innovation**
Value will be placed on other innovative factors, such as the integration of digital technologies, the development of high-impact solutions and the implementation of disruptive approaches in the processes.

Seven. SELECTION COMMITTEE

The **Selection Committee**, made up of renowned professionals, will be designated by **ASOFAP** and **FIRA DE BARCELONA**.

The Committee may request additional information on the submitted proposals if it deems it necessary to do so.

Eight. PRIZE

- The **Selection Committee** will select a maximum of **three proposals for the final of each category** from among all the products submitted.
- **One winner per category** will then be selected from the finalists upon the basis of the evaluation criteria established in **section 6 of the Terms and Conditions**.
- All the finalists will also receive **a diploma**.
- The awards cannot be declared null and void, nor can there be **a tie**.

Nine. PRESENTATION OF THE AWARDS

The decision will be announced and the awards will be presented at a ceremony to be held on **17 November 2025** in the **Outdoor & Wellness Experience** area.

Ten. EXCLUSIONS

10.1. No entries that are not properly individualised due to a lack of the corresponding personal information will be accepted, nor any that do not allow the holder's identification, any that are a mere photocopy and any that have been tampered with, altered or damaged. These entries will be excluded from the Competition

10.2. Nor will any entry be accepted if it is not duly filled in as indicated in section 5 of this document. These entries will be excluded from the call.

Eleven. RESTRICTIONS

11.1. If it is found that any of the participants do not meet the requirements set out in the Rules, or that the information provided to participate is invalid, their participation shall be deemed null and void and they shall be automatically disqualified from the Promotion, losing any rights to any awards given on the basis of this Promotion.

11.2. The following persons may not take part in the Competition:

- Workers employed by FIRA INTERNACIONAL DE BARCELONA (and the other legal entities associated to it), or any of their direct relatives.
- Any other natural person who has participated directly or indirectly in the organisation of this Promotion or has been involved directly or indirectly in its preparation or implementation (agency, suppliers, exhibitors, etc.).

2. For what purpose do we process your data?

We process the data that you have provided to us for the following purposes:

5. To whom will we disclose your data?

6. What are your rights when you provide us with your data?

Any person has the right to obtain clear and comprehensible information about whether FIRA DE BARCELONA is processing their personal data.

Data subjects have the right to access their personal data and to request the rectification of any inaccurate data or, as applicable, request the data be deleted when, among other reasons, the data is no longer necessary for the purpose for which it was provided, and to withdraw the consent granted. The exercise of the right to object to the processing of your data for the sending of advertising information electronically. You can also exercise your right to the restriction of the processing so that your data will not be deleted; however, its processing will be subject to restrictions.

The exercising of the rights to portability and not to be subjected to automated decisions do not apply in this case due to the type of data and its processing.
