RULES OF ACCESS TO THE TRADE SHOW

FHG forum – Food & Hospitality, Tourism and Gastronomy forum (hereafter FHG forum) is a trade show for professionals and prescribers that aims to be the meeting point for professionals in the agri-food industry and its value chain, as well as hospitality, tourism and food service sectors.

FHG forum will be an event with a hybrid format: a physical event complemented by virtual activities, which will allow to improve the experience for the attendees and broaden the audience beyond the physical event. If the event cannot be held in a physical format at Fira de Barcelona facilities due to health safety reasons, all the planned activities will be carried out digitally, adapting them to the existing circumstances and with the consequences detailed in this document.

FHG forum – Physical event:

Access to the venue means automatic acceptance of the following rules:

Access and registration:

- Access to FHG forum is exclusively for professionals from the agri-food, hospitality, tourism and food service sectors, during celebration days and within the opening hours.
- FHG attendees must be duly registered. The visitor badge is individual and non-transferable. Access to the venue will be done showing the badge in the mobile phone, and it will be obligatory to have the badge always available. In the event of any incident related to the badge, the attendee must go to the registration front desk (with the corresponding identification) in order to have their badge resent.
- FHG forum has an access control system with Anti-Passback technology, which
 prevents a badge from being used on more than one occasion to access the venue
 without having previously left it. Any attempt of fraud shall result in the annulment of
 the said badge by the Organisers.
- Official identification. For security reasons and at all times, attendees must carry their
 official identification document with a valid photo (National ID Card or Passport), as
 well as the corresponding badge for the event.
 - At any time, the Organisers may carry out identity checks and will be able to request the attendees to show their required official identification. These checks may be carried out, among other cases, at the access controls to the venue and even inside the venue both during the assembly and dismantling phase and during the event celebration days. In the event that having made the relevant checks the identity of the holder of the official badge does not match his or her identity document, the Organisation reserves the right to annul the badge, and the said person must therefore leave the venue immediately.

- Visitors <u>under 18 years of age</u> (alone or accompanied) are <u>not permitted.</u>
- Notwithstanding the above, professional workers who are under 18 may enter the
 event in order to carry out their professional activity. However, the sale and
 consumption of alcohol to minors under the age of 18 is strictly prohibited.

Compliance with sanitary measures:

According to the recommendations and standards established by the WHO and/or the national authorities for the control of diseases with risk of contagion, including epidemics and pandemics, the attendee commits to fully comply with the protocols that the Organisers may implement to ensure health and safety at FHG forum. Miscellaneous:

- Organisers reserve the right to admit participants and to annul their badge for noncompliance with these Rules of Access, without reimbursing the amounts paid for the purchase.
- Street vending and distribution of unauthorised advertising is not permitted. In the
 event of non-compliance, the Organisers may cancel the badge and the person affected
 must therefore leave the venue.
- Access with animals is not permitted, except as provided by law.
- Smoking is prohibited inside the halls and in enclosed areas.
- Limited capacity. Access to the venue is conditioned according to visitor-capacity limits.

FHG forum – Digital event:

In the event that for health security reasons the physical celebration of the FHG forum is not recommended (as indicated in the second paragraph of these Rules of Access), and the full event must be developed in digital format (DIGITAL EXPERIENCE), the Organisers will proceed to reimburse the difference between the amounts paid for the badge for the physical event and the badge for the online event.
