

## Rules for Innovative Service and/or Project

### BARCELONA BUILDING CONSTRUMAT 2017 AWARDS FOR INNOVATIVE SERVICE AND/OR PROJECT RULES

#### 1. PRODUCTS OR SERVICES THAT CAN BE NOMINATED TO PARTICIPATE

Innovative services and/or projects exhibited at the Show and related to the construction sector are eligible for the award as well as participants in the 'Project and/or service presentation Call at the Future Arena Technical Corner'. Projects or services that have been selected as finalists in previous editions may not be submitted.

#### 2. WHO CAN NOMINATE THE WORKS

Proposals that you wish to nominate for the Awards must be submitted by the natural or legal person holding the space or by the person responsible for the space in which they are displayed at the Show. The proposer is responsible for the accuracy of information and compliance with current intellectual property laws. As many proposals as deemed appropriate may be submitted, but one registration must be issued for each proposal.

#### 3. REGISTRATION AND DOCUMENTATION

Registration will take place online through the exhibitor's private area <http://www.construmat.com/ca/inscripcion-call-technical-corner>. The registration form must be filled in before 23:59 GTM+2 on 31 March 2017, according to the participation method:

- Method 1: Completing the participation form for the Technical Corner + call for the BBC Awards in the Innovative Service and/or Project category.
- Method 2: Completing the exclusive participation form for the BBC Awards call in the Innovative Service and/or Project category.

and submitting the following descriptive documents:

- A4 data sheet in PDF format (not exceeding 5 MB) and including the following information:
  - Innovative service and/or project description.
  - Technical and graphical information of the innovative service and/or project.
  - Representative photo(s) of the innovative service and/or project.

Registration is **FREE**, it can only be carried out online and is only valid if the documentation is submitted within the time periods specified in these rules.

#### 4. INTELLECTUAL PROPERTY RIGHTS

The awards organisation reserves the right to reproduce the selected and awarded products and/or services' information and images in all documented media deemed necessary. The proposals submitted in this call and not selected as finalists shall not be made public.

The winning proposals, finalists and those who have been mentioned (if any) may make a note of the distinction obtained in their technical documentation.

#### 5. PARTICIPATION AND QUERIES DEADLINES

The deadline for proposal submission is 23:59 GTM+2 on 31 March 2017.

## 6. JURY AND TECHNICAL SECRETARIAT

The jury will be composed of renowned professionals and academics selected by the Mies van der Rohe Foundation, centre for research, discussion and promotion of architectural culture.

## 7. SELECTION CRITERIA

The evaluation of proposals will be based on the following criteria:

- Degree of innovation of the innovative service or project
- Social and/or architectural impact of the innovative service or project
- Environmental impact of the innovative service or project
- Economic impact of the innovative service or project

## 8. COMMUNICATION

The Technical Secretariat of the Awards will notify participants of the finalist proposals two weeks before the Show.

## 9. AWARD

The Award is granted to the natural or legal person submitting and/or exhibiting the proposal at the Show. If the jury considers it appropriate, it may grant mentions.

The prize consists of an award and a diploma for the natural or legal owner of the winning innovative service or product.

The final proposals will receive a diploma.

Awards may not be declared void or granted ex aequo.

## 10. INCIDENTS

It will be the Jury's sole responsibility to resolve any issues that may arise regarding the granting of the awards. The Jury's decisions are unquestionable.

## 11. AWARDS CEREMONY

The reading of the verdict and the awards ceremony will take place at a public event to be held on Wednesday, 24 May 2017 at the Show.

Participation in these awards implies acceptance of these rules.
