

Stand Award Rules

BARCELONA BUILDING CONSTRUMAT STAND 2017 AWARDS

1. STANDS THAT CAN BE NOMINATED TO PARTICIPATE

All stands built in the Building Construmat Barcelona 2017 Show are eligible to participate.

2. WHO CAN NOMINATE THE STAND

The stands that you wish to nominate for the awards can be presented by the natural person or legal owner of the space or person responsible therefor.

3. REGISTRATION AND DOCUMENTATION

Registration will take place online through the exhibitor's private area <http://www.construmat.com/formulario-stand-premios-bbconstrumat>. The form must be completed and the following documents submitted exclusively in digital format:

- Technical and graphic data (drawings, specifications, infographics) in free format and in PDF not exceeding 5 MB. The first page of the PDF must be in A4 format and must include the following information:
 - Name of the exhibiting company.
 - Agents who have participated in the stand's design and construction.
 - Stand description, specifying the design strategy, innovation and sustainability criteria adopted and its ability to communicate the values and potential of the product or service offered.

Registration is **FREE**, it can only be carried out online and is only valid if the documentation is submitted within the time periods specified in these rules.

4. INTELLECTUAL PROPERTY RIGHTS

The awards organisation reserves the right to reproduce the selected and award-winners' information and images in all documented media deemed necessary. The proposals submitted in this call and not selected as finalists shall not be made public.

The winning proposals, those who have been mentioned and finalists may make note of the distinction obtained in their technical documentation and media.

5. PARTICIPATION AND QUERIES DEADLINES

The deadline for proposal submission is 23:59 GTM+2 on 31 March 2017.

6. JURY AND TECHNICAL SECRETARIAT

The jury will be composed of renowned professionals and academics selected by the Mies van der Rohe Foundation, centre for research, discussion and promotion of architectural culture.

The composition of the Jury will be published on the competition website <http://www.construmat.com/premios-bb-construmat-2017> in early March.

Any additional information requested by the Jury should be made available.

The Technical Secretariat for the requested documentation for participating in the Barcelona Building Construmat 2017 Awards is Barter Partnership, C/ Aragó 179, 1º 1ª Barcelona, Spain.

7. SELECTION CRITERIA

The Jury will consider the following criteria to give its verdict:

- The quality of architectural design and technical excellence in the Stand's execution
- Criteria for innovation and design sustainability
- The ability to communicate the values and potential of the exhibiting company's product and/or service.

A selection of final proposals from among all the works submitted which meet the terms of the call will be carried out by the jury. The finalists will be part of a highlighted stands route.

The jury will visit the finalist stands at the trade show for assessment before issuing its verdict. The award for the best Barcelona Building Construmat 2017 Stand will be granted from among the previously selected proposals.

Visitors to the show may follow the finalist stands route and vote for the best stand. The award from the public will be independent to the award granted by the Barcelona Building Construmat 2017 jury.

8. COMMUNICATION

The Technical Secretariat of the Awards will notify participants of the finalist proposals two weeks before the Show.

9. AWARD

The Award is given to the natural or legal person responsible for the stand.

The prize consists of an award and a diploma for the stand's natural or legal owner.

Agents who have participated in the winning stand's design and construction will receive a diploma.

The finalists will receive a diploma.

Awards may not be declared void or granted ex aequo.

10. INCIDENTS

It will be the Jury's sole responsibility to resolve any issues that may arise regarding the granting of the awards. The Jury's decisions are unquestionable.

11. AWARDS CEREMONY

The reading of the verdict and the awards ceremony will take place at a public event to be held on Wednesday, 24 May 2017 at the trade show.

12. ACCEPTANCE OF THE RULES

Participation in these awards implies acceptance of these rules.
