#### **GENERAL TERMS & CONDITIONS**

Only the companies exhibiting at Alimentaria 2018 (direct or represented) can participate in the Gourmet Olive Oil Bar.

Each participating company must deliver **four** ½ **litre bottles** of each of the references presented, for their exhibition in the Gourmet Olive Oil Bar. The organisation will communicate to the participating companies the exact date and time for the product delivery.

The Gourmet Olive Oil Bar is divided into three exhibition areas, according to the characteristics of the presented oils:

#### Conventional EVOO

The olive oils presented in this area must be **extra virgin and presented in glass bottles or cans**. Plastic packaging or other low quality presentations will not be allowed.

#### Organic EVOO

The olive oils presented in this area must have the **Organic Farming certification** from the European Union and also be presented in **glass bottles of cans**.

#### **SPECIALTIES**

This area presents those olive oils which contain olive oil, virgin olive oil or extra virgin olive oil as the base ingredient. Additionally, other ingredients should be: aromatic herbs, plants, spices, fruits, etc. or the oil should have suffered modifications that altered its organoleptic profile (e.g. smoking, aromatic).

#### **TERMS OF PAYMENT**

100% of the participation fee requested in this PARTICIPATION CONTRACT must be paid via cheque or bank transfer to Fira Internacional de Barcelona. The **proof of payment** should be submitted together with this PARTICIPATION CONTRACT.
