

1. WHICH PROJECTS CAN PARTICIPATE?

All products and projects exposed during the Piscina & Wellness Barcelona 2017 Event, organized by FIRA DE BARCELONA, that have been presented in the current call for innovative products.

Those which have already registered to the Call for Products will compete directly to Award.

Products or materials that have been selected finalist in previous years are not allowed to be presented this time.

2. WHO CAN SUBMITT A PROJECT

The installations willing to be eligible to these awards should be submitted through the physical person owning the project or by the legal representatives of entities owning the project. The projects may also be submitted by the agents (promotion, project, direction of project or execution, construction) who have taken part during the building if authorised by the project owner. The person submitting the project will be responsible for the veracity of the submitted information to the Organisation.

It is possible to submit more than one project, but it is necessary to do a new inscription for each project.

The inscription to the Awards will only be accepted if all the documentation in point 3 is submitted.

3. REGISTRATION AND DOCUMENTATION

The registration will be made through the Exhibitor area on the website before 23:59h, GTM+2, June 19, 2017.

The following documentation is required:

a) form: The inscription will be made online using the online form available on the exhibitor area on the website, before 23:59h, GTM+2, **June 19, 2017.**

Once completed, the submitter will receive a confirmation through the email address indicated in the registration form.

Afterwards, the submitter has to present the following documentation before the deadline detailed above:

- a) GRAPHIC AND TECHNICAL INFORMATION: Catalogs, brochures, maps, certificates, etc as a .pdf, .jpg or .doc
- b) PHOTOS: as a .jpg (at least two)

The graphic and technical information and photos should be attached in a single zip or rar file, which shouldn't be bigger than 25Mb, and should be sent via email to piscinawellness.secretaria@firabarcelona.com

The information must be in Spanish, Catalan or English. Submissions in other languages will not be accepted.

*The participation is **FREE**. The only inscription modality is on-line and will only be acceptable if the requested documentation is sent within the previously specified deadline.*

4. AUTOMATIC PARTICIPATION IN THE INNOVATION AREA

The registration in the Innovative Product Award allows to display the presented product in the Innovation Poster Area that to be held during the event. For more display options in this area (podium and / or presentation) please refer to the exhibitor's private area.

5. INTELLECTUAL PROPERTY RIGHTS

All the projects submitted will cease their rights, so that FIRA DE BARCELONA can publish them for information and dissemination purposes in any format that FIRA DE BARCELONA retains convenient. Owners will always be mentioned on those materials and are accountable for the application submitted not violating intellectual property rights, industrial property rights, copyright and/or image rights and assumes complete responsibility regarding third parties: The Organization is free of all liability in case of a claim of this nature. Furthermore, the participants are responsible for any claim presented by any Intellectual Property Entities.

6. PARTICIPATION TERMS AND QUERIES

The inscription period will end at 23:59h, GTM+2, on **June 19, 2017**.

7. JURY AND TECHNICAL SECRETARIAT

The Jury will consist of widely recognized professionals. The Jury will be made known during the Awards-giving Ceremony, in which the awarded projects will also be made known.

The Jury can request, if it deems it necessary, additional information regarding the submitted projects.

8. EVALUATION CRITERIA

The Jury will give the Piscina & Wellness Barcelona Award for the Innovative Product 2017 to the product, system or service that gives a significant contribution through its built process, use, maintenance or rehabilitation of residential pools, wellness centers and facilities for public pools. Furthermore, will be explicitly evaluated that product or process to go for an efficient use of resources (water, energy, raw materials) and for its respect to the environment throughout their life cycle (manufacturing, deployment, operation, demolition and recycling).

9. COMMUNICATION

The decision of the jury will be communicated by the Technical Secretariat via email to the awarded participants two weeks prior to the event.

10. AWARDS

The Jury will give the Piscina & Wellness Barcelona award for the Innovative Product 2017 to that product considered the winner according to the evaluation criteria specified in the point number 7. The jury will select a maximum of 3 finalists among all submitted products and one winner will be selected among these finalists.

The award consists in a diploma and a trophy that will be given to the natural or legal person (through its legal representative or authorised person by the organization that receive the award on his behalf) that has presented and exposed the product during Piscina & Wellness 2017 Event.

The finalists will also receive a diploma.

Prizes can not be declared void or granted ex aequo.

10. CLAIMS

It is the Jury's duty to solve any incidence regarding the Awards adjudication. The Jury's decisions are not subject to appeal.

11. AWARDS GIVING

The verdict communication and the awards giving will take place during a public Ceremony that will be held on October 18th 2017 in the Casa Llotja de Mar (Barcelona), within the Piscina & Wellness Barcelona 2017 Event.
