

GUIDELINES FOR THE AWARDS "POOLS OF INSTALLATIONS IN USE" PISCINA & WELLNESS BARCELONA 2017

1. WHICH PROJECTS CAN PARTICIPATE?

All public pools, either new or rehabilitated, completed between **September 1st 2015 and May 31st 2017** submitted to this call organized by Fira de Barcelona are eligible to the Piscina & Wellness Barcelona 2017 Awards "Pools of installations in use".

Categories:

- Best Residential Pool
- Best Wellness Centre Pool
- Best Pool of public use.
- Best Rehabilitated Pool

2. WHO CAN SUBMITT A PROJECT

The installations willing to be eligible to these awards should be submitted through the physical person owning the project or by the legal representatives of entities owning the project. The projects may also be submitted by the agents (promotion, project, direction of project or execution, construction) who have taken part during the building if authorised by the project owner. The person submitting the project will be responsible for the veracity of the submitted information to the Organisation.

It is possible to submit more than one project, but it is necessary to do a new inscription for each project.

The inscription to the Awards will only be accepted if all the documentation in point 3 is submitted.

3. REGISTRATION AND DOCUMENTATION

a) form: The inscription will be made online using the online form available on the website, before 23:59h, GTM+2, **June 19, 2017**.

Once completed, an additional file will be sent to the email indicated in the registration form. This file, the project sheet, must be completed with the requested information. It has an extension of 2 pages and must be sent in format A4 and as a .pdf.

b) project sheet: On page 1 should appear:

- Kind of project, location and finalization date.
- Data of the person submitting the project (promotor) or of the agent who took part in the project (authorised by the project owner).
- Data of the remaining agents who took part in the project (project, direction of project or execution, construction, installation of the pool)
- Description of the project
- Aspects of innovation and sustainability present in the project.

Page 2 will be exclusively for the graphic information: photographs and plans. Project sheets with an extension longer than 2 pages won't be accepted.

Additionally, to the Project Sheet, the following information must be submitted as well:

c) additional information: Additionally, to the Project Sheet, you are required to send photographs in jpg format (maximum 8, one file per Picture), the necessary plans to understand the project in .pdf format. Even if the photographs and plans have been included in the Project Sheet, they should be sent as well in the requested formats

d) document or certificate accrediting the building finalization date: Issued by the corresponding entity as a .jpg or .pdf format.

The Project Sheet, the Additional Information and the Certificate should be attached in a single zip or rar file, which shouldn't be bigger than 25Mb, and should be sent via email to: piscinawellness.secretaria@firabarcelona.com

The information must be in Spanish, Catalan or English. Submissions in other languages will not be accepted.

*The participation is **FREE**. The only inscription modality is on-line and will only be acceptable if the requested documentation is sent within the previously specified deadline.*

4. INTELLECTUAL PROPERTY RIGHTS

All the projects submitted will cease their rights, so that FIRA DE BARCELONA can publish them for information and dissemination purposes in any format that FIRA DE BARCELONA retains convenient. Owners will always be mentioned on those materials and are accountable for the application submitted not violating intellectual property rights, industrial property rights, copyright and/or image rights and assumes complete responsibility regarding third parties: The Organization is free of all liability in case of a claim of this nature. Furthermore, the participants are responsible for any claim presented by any Intellectual Property Entities.

The proposals which are not selected as candidates to award won't be made public.

5. PARTICIPATION TERMS AND QUERIES

The inscription period will end at 23:59h, GTM+2, on **June 19, 2017**.

The Jury will consist of widely recognized professionals. The Jury will be made known during the Awards-giving Ceremony, in which the awarded projects will also be made known.

7. EVALUATION CRITERIA

The Jury will consider the innovative aspects of the project, as well as the sustainability criteria of the installation both in the use of resources and their life-cycle.

8. COMMUNICATION

The decision of the jury will be communicated by the Technical Secretariat via email to the awarded participants two weeks prior to the event.

9. AWARDS

The Jury will give the following awards:

- Award Piscina & Wellness Barcelona 2017 to the Best Residential Pool
- Award Piscina & Wellness Barcelona 2017 to the Best Wellness Centre Pool
- Award Piscina & Wellness Barcelona 2017 to the Best Pool of Public Use
- Award Piscina & Wellness Barcelona 2017 to the Best Rehabilitated Pool

The Jury will select a maximum of 3 finalist proposals for each category among the submitted proposals, and will then choose a winner for each category.

The Award, consisting of a certificate and a trophy, will be given to the project owners submitting the proposal or to the agents submitting the proposals who have been authorised by the project owners.

The finalists will receive a certificate as well.

Awards may not be declared void nor given ex aequo.

10. CLAIMS

It is the Jury's duty to solve any incidence regarding the Awards adjudication. The Jury's decisions are not subject to appeal.

11. AWARDS GIVING

The verdict communication and the awards giving will take place during a public Ceremony that will be held on October 18th 2017 in the Casa Llotja de Mar (Barcelona), within the Piscina & Wellness Barcelona 2017 Event.
